Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into the competition is deemed acceptance of these terms and conditions.
2. Entry is open to all residents of Australia who are 18 years of age or over. However, employees and their immediate families of The Art Gallery of South Australia, Singapore Airlines, Peregrine Travel Centre, and their associated agencies and companies are not eligible to enter.
3. The competition commences on Saturday 13 June, 2015 at 09:00 (ACST) and concludes on Sunday 30 August, 2015 at 18:00 (ACST).

 - i. Attend the '*Treasure Ships: Art in the Age of Spices (Treasure Ships)*' exhibition' and complete the entry forms available on designated computer terminals located within the gallery. Entrants will be required to register their details including (but not limited to) name, full address, phone number, age, gender and e-mail address to qualify a valid entry. Or;
 - ii. Visit www.treasureships.com.au and register their details including (but not limited to) name, full address, phone number, age, gender and e-mail address to qualify a valid entry
6. Incomprehensible and incomplete entries will be deemed invalid.
7. Entrants may only enter once per *Treasure Ships* exhibition ticket purchased.
8. The Promoter reserves the right to request winners to provide proof of identity, proof of residency at the nominated prize delivery address and/or proof of entry validity in order to claim a prize. Proof of identification, residency and entry considered suitable for verification is at the discretion of the Promoter. In the event that a winner cannot provide suitable proof, the winner will forfeit the prize in whole and no substitute will be offered.

The Promoter reserves the right to disqualify a winner if Promoter becomes aware that the winner and/or the winner's entry is of a type described in this clause.
10. Entries must be received by 18:00 (ACST) on Sunday 30 August, 2015. The time of entry will in each case be the time the entry is received by the Promoter's database. The Promoter accepts no responsibility for any late, lost or misdirected entries due to technical disruptions,

network congestion or for any other reason.

11. Any entry that is made on behalf of an Entrant by a third party will be invalid.
